Dear Edgar

It was both a great pleasure and most informative to meet with you and many of our WJC colleagues at the Governing Board meeting in Jerusalem earlier this month. I found my discussions with Stephen Herbits of great value and believe we have the potential for an excellent ongoing working relationship.

I write following discussion of the issue of the aftermath of the New York Attorney-General's report by the ECAJ Committee of Management.

At its 23 February 2006 meeting the ECAJ Committee of Management resolved to convey to you and the WJC Governing Board its deep disappointment in, and dissociation from, the decision of the WJC to commence legal proceedings in Israel against Mr. Isi Leibler AO CBE.

The Resolution is enclosed with this letter. The Committee of Management wishes you to understand that its strong views on this matter are offered on behalf of the community committed to a successful and well regarded World Jewish Congress.

The ECAJ requests that the WJC circulate the Resolution, with this letter, to all officers, Governing Board members and member communities of the WJC.

We await your positive response and advice that the proceedings have been, or will be, discontinued.
